### Linda Michelle Weinberger, UC Irvine

## Bylaws Update

Earlier this month, members of the CUE-Teamsters Bylaws Committee met for the second time with legal counsel to draft a new set of governing rules for Local 2010 as required by the affiliation agreement with the Teamsters. The committee members are: Mary Higgins (UCSF); Jorge Rodriguez (UCM); Dorie De Costa (UCD); Kristi Rank (UCSB); Di Dickerson (UCLA); Mary Juma (UCR); Dianna Sahhar (UCI); and Dorthea Stewart (UCSD). In addition, the committee includes the following officers who serve as advisors: Anytra Henderson (Acting President); Stephanie Dorton (Secretary); Maria La Barrie (Southern VP); Ginger Jones (Acting Treasurer); Amatullah Alaji-Sabrie (Chief Negotiator). Stay tuned for more information on the proposed new bylaws, including the process for member consideration and adoption.

## Electing Delegates

In 2011, all full CUE-Teamster members will be voting for delegates to attend the Teamster Convention next summer where the Teamsters General President, General Secretary-Treasurer, Vice Presidents and Trustees will be nominated. If you are not sure whether you are a voting member, check your monthly statement of earnings. At the bottom under deduction, if it says, "CUE Dues" you are a voting member. If not, please contact your local CUE-Teamster office so that you can become a voting member.

We are only going to get a contract if we are united and organized. Let's continue sending UC the message that we will maintain our fight for a new contract! Wear t-shirts and participate in the Communication Action Network (CAN).
